

SENATE JOINT RESOLUTION NO. _____

1 Proposing amendments to Section 2 of Article V and Sections 4 and 5 of Article VII of the Constitution
2 of Virginia and proposing an amendment to the Constitution of Virginia by adding in the Schedule
3 a section numbered 6, relating to moving the election of certain offices to even numbered years.

4 RESOLVED by the Senate, the House of Delegates concurring, a majority of the members elected
5 to each house agreeing, That the following amendments to the Constitution of Virginia be, and the same
6 hereby are, proposed and referred to the General Assembly at its first regular session held after the next
7 general election of members of the House of Delegates for its concurrence in conformity with the
8 provisions of Section 1 of Article XII of the Constitution of Virginia, namely:

9 Amend Section 2 of Article V and Sections 4 and 5 of Article VII of the Constitution of
10 Virginia of the Constitution of Virginia and amend the Constitution of Virginia by adding in the Schedule
11 a section numbered 6 as follows:

12 ARTICLE IV

13 Section 2. Senate.

14 The Senate shall consist of not more than forty and not less than thirty-three members, who shall
15 be elected quadrennially by the voters of the several senatorial districts on the Tuesday succeeding the
16 first Monday in November.

17 Section 3. House of Delegates.

18 The House of Delegates shall consist of not more than one hundred and not less than ninety
19 members, who shall be elected biennially by the voters of the several house districts on the Tuesday
20 succeeding the first Monday in November.

21 ARTICLE V

22 Section 1. Executive power; Governor's term of office.

23 The chief executive power of the Commonwealth shall be vested in a Governor. He shall hold
24 office for a term commencing upon his inauguration on the Saturday after the second Wednesday in
25 January, next succeeding his election, and ending in the fourth year thereafter immediately upon the

26 inauguration of his successor. He shall be ineligible to the same office for the term next succeeding that
27 for which he was elected, and to any other office during his term of service.

28 Section 2. Election of Governor.

29 The Governor shall be elected by the qualified voters of the Commonwealth ~~at the time and place~~
30 ~~of choosing members of the General Assembly on the Tuesday succeeding the first Monday in November.~~

31 Returns of the election shall be transmitted, under seal, by the proper officers, to the State Board of
32 Elections, or such other officer or agency as may be designated by law, which shall cause the returns to
33 be opened and the votes to be counted in the manner prescribed by law. The person having the highest
34 number of votes shall be declared elected; but if two or more shall have the highest and an equal number
35 of votes, one of them shall be chosen Governor by a majority of the total membership of the General
36 Assembly. Contested elections for Governor shall be decided by a like vote. The mode of proceeding in
37 such cases shall be prescribed by law.

38 Section 13. Lieutenant Governor; election and qualifications.

39 A Lieutenant Governor shall be elected at the same time and for the same term as the Governor,
40 and his qualifications and the manner and ascertainment of his election, in all respects, shall be the same,
41 except that there shall be no limit on the terms of the Lieutenant Governor.

42 Section 15. Attorney General.

43 An Attorney General shall be elected by the qualified voters of the Commonwealth **at the same**
44 **time and for the same term as the Governor**; and the fact of his election shall be ascertained in the same
45 manner. No person shall be eligible for election or appointment to the office of Attorney General unless
46 he is a citizen of the United States, has attained the age of thirty years, and has the qualifications required
47 for a judge of a court of record. He shall perform such duties and receive such compensation as may be
48 prescribed by law, which compensation shall neither be increased nor diminished during the period for
49 which he shall have been elected. There shall be no limit on the terms of the Attorney General.

50 ARTICLE VII

51 Section 4. County and city officers.

52 There shall be elected by the qualified voters of each county and city a treasurer, a sheriff, an
53 attorney for the Commonwealth, a clerk, who shall be clerk of the court in the office of which deeds are
54 recorded, and a commissioner of revenue. The duties and compensation of such officers shall be prescribed
55 by general law or special act.

56 Regular elections for such officers shall be held on the Tuesday ~~after~~ succeeding the first Monday
57 in November. Such officers shall take office on the first day of the following January unless otherwise
58 provided by law and shall hold their respective offices for the term of four years, except that the clerk
59 shall hold office for eight years.

60 The General Assembly may provide for county or city officers or methods of their selection,
61 including permission for two or more units of government to share the officers required by this section,
62 without regard to the provisions of this section, either (1) by general law to become effective in any county
63 or city when submitted to the qualified voters thereof in an election held for such purpose and approved
64 by a majority of those voting thereon in each such county or city, or (2) by special act upon the request,
65 made after such an election, of each county or city affected. No such law shall reduce the term of any
66 person holding an office at the time the election is held. A county or city not required to have or to elect
67 such officers prior to the effective date of this Constitution shall not be so required by this section.

68 The General Assembly may provide by general law or special act for additional officers and for
69 the terms of their office.

70 Section 5. County, city, and town governing bodies.

71 The governing body of each county, city, or town shall be elected by the qualified voters of such
72 county, city, or town in the manner provided by law.

73 If the members are elected by district, the district shall be composed of contiguous and compact
74 territory and shall be so constituted as to give, as nearly as is practicable, representation in proportion to
75 the population of the district. When members are so elected by district, the governing body of any county,
76 city, or town may, in a manner provided by law, increase or diminish the number, and change the
77 boundaries, of districts, and shall in 1971 and every ten years thereafter, and also whenever the boundaries
78 of such districts are changed, reapportion the representation in the governing body among the districts in

a manner provided by law. Whenever the governing body of any such unit shall fail to perform the duties so prescribed in the manner herein directed, a suit shall lie on behalf of any citizen thereof to compel performance by the governing body.

~~Unless otherwise provided by law, the governing body of each city or town shall be elected on the second Tuesday in June and take office on the first day of the following September. Unless otherwise provided by law, the~~ The governing body of each county, city, or town shall be elected on the Tuesday ~~after succeeding~~ the first Monday in November of an even numbered year and take office on the first day of the following January.

SCHEDULE

Section 6. Moving the election of certain offices to even numbered years.

Notwithstanding the provisions of Section 2 of Article IV, the term of office for any seat in the Senate elected on the Tuesday succeeding the first Monday in November of 2031 shall be three (five) years. The regular quadrennial election of senators shall begin again on the Tuesday succeeding the first Monday in November of 2034 (2036) and proceed every 4 years thereafter.

Notwithstanding the provisions of Section 3 of Article IV, the term of office for any seat in the House of Delegates elected on the Tuesday succeeding the first Monday in November of 2029 shall be one year (three years). The regular biennial election of Delegates shall begin again on the Tuesday succeeding the first Monday in November of 2030 (2032) and proceed every 2 years thereafter.

Notwithstanding the provisions of Section 1 of Article V, the term of office for the Governor elected on the Tuesday succeeding the first Monday in November of 2029 shall be three (five) years. The regular quadrennial election for Governor shall begin again on the Tuesday succeeding the first Monday in November of 2032 (2034) and proceed every 4 years thereafter. Pursuant to the sections 13 and 15 of Article V the Lieutenant Governor and Attorney General shall be elected at the same time and for the same terms as the Governor as indicated by this section.

Notwithstanding the provisions of Section 4 of Article VII the term of office for any treasurer, sheriff, or attorney for the Commonwealth elected on the Tuesday succeeding the first Monday in November of 2029 shall be three years (five years). The regular quadrennial elections for such offices

shall begin again on the Tuesday succeeding the first Monday in November of 2032 (2034) and proceed every 4 years thereafter.

Notwithstanding the provisions of Section 4 of Article VII the term of office for any treasurer, sheriff, or attorney for the Commonwealth elected on the Tuesday succeeding the first Monday in November of 2031 shall be three years (five years). The regular quadrennial elections for such offices shall begin again on the Tuesday succeeding the first Monday in November of 2034 (2036) and proceed every 4 years thereafter.

Notwithstanding the provisions of Section 4 of Article VII the term of office for any treasurer, sheriff, or attorney for the Commonwealth elected on the Tuesday succeeding the first Monday in November of 2033 shall be three years (five years). The regular quadrennial elections for such offices shall begin again on the Tuesday succeeding the first Monday in November of 2036 (2038) and proceed every 4 years thereafter.

Notwithstanding the provisions of Section 4 of Article VII the term of office for any clerk of the court elected on the Tuesday succeeding the first Monday in November of 2031 shall be three years (five years). The regular quadrennial elections for such offices shall begin again on the Tuesday succeeding the first Monday in November of 2034 (2036) and proceed every 4 years thereafter.

Notwithstanding the provisions of Section 4 of Article VII the term of office for any clerk of the court elected on the Tuesday succeeding the first Monday in November of 2035 shall be three years (five years). The regular quadrennial elections for such offices shall begin again on the Tuesday succeeding the first Monday in November of 2038 (2040) and proceed every 4 years thereafter.
